From the Preliminary Market Consultation preceding the initiation of a public procurement procedure for the supply of single crystal processing equipment

II. Legal basis

Preliminary market consultations were conducted pursuant to Article 84 of the Law of September 11, 2019. - Public Procurement Law (i.e., Journal of Laws of 2023, item 1605, as amended).

III. Purpose, object of consultation and date of announcement of Preliminary Market Consultation:

The Procuring Entity on September 19, 2024 announced a Preliminary Market Consultation prior to the initiation of a public procurement procedure for the supply of single crystal processing equipment, viz (i) a crystal tumbler machine, (ii) a crystal edging machine, (iii) a wafer polisher, (iv) a tile grinder, (v) a base cutter (hereinafter referred to as 'Equipment').

The scope of the contract includes delivery of the Equipment, installation of the Equipment and training of the Contracting authority personnel.

Before the deadline (September 26, 2024), the Contracting Authority did not receive any applications to participate in the Preliminary Market Consultation. JB Labotech and Lapmaster responded that they do not have in their offer the Devices in which we are interested.

The other Contractors were also unwilling to participate in the consultation. The primary reason was that the Equipment we are interested in is very specialized in nature and are not in their offerings.

V. Dates and form of the preliminary market consultation to be carried out by the Employer

Due to the fact that there were no potential contractors willing to participate in the Preliminary Market Consultations, these were not held.

VII. Deadline for completion of Preliminary market consultation

The initial market consultation was terminated on September 27, 2024, after the deadline for submitting applications for participation had passed due to a lack of such applications.
